NUSI Profile

The present day National Union of Seafarers of India (NUSI) traces its origins since 1896 through the Goa Portuguese Seamens Club. The achievements of the seafarers was largely due to the personal charisma and dedication of Shri Mohamed Ebrahim Serang. He realized that the movement has to be taken on a higher platform. He decided to give the seafarers movement a proper structure of a strong trade union organization.

In the year 1926 Shri Mohamed Ebrahim Serang established the first organised trade union in the history of Indian seafarers under the name of "National Union of Seamen of India (NUSI)" and was its Founder President.

Earlier Shri Mohamed Ebrahim Serang was operating the union activities from his own premises at 47, Old Nagpada Road, Bombay 400009 (later the street was named after him in 1975). The union was receiving membership of Re 1/- from 1926 to 1948 and thereafter the membership was increased to Rs. 3/- from 1948 to 1952 to Rs. 6/-. From this subscription amount, with



much difficulty, the foundation stone of the present building of the National Union of Seafarers of India (NUSI) was laid on 6th January, 1950. The building was completed at a cost of around Rs. 1 lakh entirely from the subscription of the seafarers and the sacrifices of all those present at that point of time. It was a proud moment for Indian seafarers to have a union building of their own.

The National Union of Seafarers of India (NUSI) got affiliated with the International Transport Workers Federation (ITF) and the Hind Mazdoor Sabha (HMS) to give better support to our Indian seafarers even in foreign waters.

Shri Mohamed Ebrahim Serang retired from active unionism on his 80th birthday and expired on 2nd September, 1963 at the age of around 85 years leaving behind a rich legacy for which he is rightly called the "Father of Indian Seafarers Movement"

NUSI demand for Provident Fund, Gratuity and Pension to all ranks of our seafarers working on Indian and foreign flagships of all types will start soon

You are aware that it was entirely due to the **NUSI protest in Delhi in 1963** outside the Hon'ble Indian Parliament which led to enactment of the Seamen's Provident Fund Act, 1966 for the Indian flag ships.

Provident Fund is only statutory in Indian flag ships. But for decades all NUSI agreements agreed bilaterally on Indian flag or foreign flag to have Provident Fund, Gratuity and Annuity for the welfare of our seafarers.



Vide our circular no 001 of 2023 dated 6th January, 2023 NUSI had informed vou that the NUSI of demand Provident Fund, Gratuity and Pension for all ranks of our seafarers serving on Indian and foreign flagships of all types was formally accepted on 6th

January, 2023. The final draft is now being sent to the Government of India for final approval to be adopted by the Hon'ble Indian Parliament.

NUSI will ensure that the existing benefits are retained and improved upwards when the final scheme of PF, Gratuity and Pension is implemented.

We thank the Government of India and the Board of Trustees of the Seamen's Provident Fund for agreeing to this long pending demand of NUSI.

HIGHLIGHTS IN SHIPPING INDUSTRY



Inauguration of 60th Merchant Navy Week by His Excellency Shri Ramesh Bais, Governor of Maharashtra

The Hon'ble Governor of Maharashtra, Shri Ramesh Bais inaugurated the Merchant Navy Week at Raj Bhavan Mumbai on Friday, 31st March, 2023. Director General of Shipping & Chairman NMDC (Central) Committee Shri Rajiv Jalota, IAS pinned the miniature flag of Merchant Navy Day on the apparel of the Hon'ble Governor to mark the inauguration of the beginning of the Diamond Jubilee of Merchant Navy Week. NMDC Committee Members along with heads of the various Organisations and unions in maritime sector were present on the occasion.

Seamen's Provident Fund Organization (SPFO) Nomination MELA

It is observed that many seafarers are not aware or have not filled their Provident Fund nomination or changing nomination post marriage. This leads to complications to settle their claim on due to death of seafarers. Thus to enhance the awareness amongst the seafarers the Seamen's Provident Fund (SPF) organized a <u>Nomination Mela</u> on 23rd February, 2023 at Indian Sailors Home Society (ISHS). Hundreds of seafarers participated the said Nomination Mela and filed their nomination successfully.

Shri Sudhansh Pant appointed as Secretary of the Ministry of Shipping



Shri Sudhansh Pant has been appointed as Secretary, Ministry of Ports, Shipping and Waterways upon the superannuation of Shri. Sanjeev Ranjan, IAS on 31.01.2023. Shri Sudhansh Pant is a 1991 batch IAS officer of Rajasthan cadre.

Seafarers Identification Documents (SID)

India has ratified the Seafarers Identification Document (SID) convention. The issuance of new Biometric Seafarers Identity Document for its seafarers commenced from 2018. The new biometric SID has the provisions for the bar coding of the biometrics based identity of seafarers and a centralized data base maintained in the issuing country, which can be accessed globally through an interoperable & standard biometric template. Director General of Shipping has issued more than 2 (two) lakh biometric SID to Indian Seafarers. It is in the interests of all seafarers to obtain the SID.

National Shipping Board (NSB) Meeting, New Delhi

The Meeting of National Shipping Board (NSB) was held on 17th February, 2023 at New Delhi. Shri Milind Kandalgaonkar, NUSI General Secretary -cum- Treasurer represented our seafarers on this very important NSB. Shri Kandalgaonkar highlighted issues regarding increase in employment of seafarers, welfare training, health facilities at ports, etc. faced by the Indian seafarers.

Hike of Indian Seafarers Globally

Shares of Indian Seafarers in Global demand set to rise twenty percent in ten years on the back of robust education system linguistic skills and young population. India is one of the major suppliers of train maritime manpower for the shipping industry globally. This rise due to aging seafarers population in European ongoing Ukraine Russia conflict and European considers Filipino seafarer ban over training deficiencies.

CONTINUATION OF NUSI SKILLS SUPPORT TRAINING SCHEME

"On the occasion of the World Maritime Day which was celebrated on September 28th 2021, NUSI in the presence of Shri Amitabh Kumar, Director-General of Shipping, and Shri Stephen Cotton, ITF General Secretary had announced the 'NUSI Skills Support' to provide financial assistance for STCW or skills enhancement courses to NUSI members during the COVID pandemic as part of the 125th year celebrations of NUSI."

Due to overwhelming response The NUSI Skills Support was extended further on the auspicious occasion of the 75th Azadi ka Amrit Mahotsav in the year 2022, to NUSI members as an Independence Day gift from NUSI. Thereafter NUSI Skills Support was further extended between the period of 1st January 2022 and 31st March 2023."

The demand for Indian seafarers is high compared to the year 2022, with an expected growth of 15% in employment this year, particularly for ratings and petty officers. This growth was supported by the NUSI Skill Support scheme, which has helped to increase the employability of Indian Seafarers. Therefore, the NUSI Executive Committee has decided to extend the "NUSI Skill Support" scheme to provide financial assistance to NUSI members for job retention. The Scheme has been extended further for the period of 1st April 2023 till 31st March 2024."

Farewell to Director General of Shipping

As you all are aware The Directorate General of Shipping, India deals with implementation of shipping policy and legislation so as to ensure the safety of life and ships at sea, prevention of marine pollution, Maritime Administration, Maritime Education and Training, development of Shipping Industry and other related subjects.

Shri Amitabh Kumar, IRS retired as Director General of Shipping. Shri Amitabh Kumar always worked towards the betterment of seafarers and shipping fraternity in general with all his dedication. In his tenure he had introduced many initiatives for seafarers, particularly during the Covid pandemic.

The initiatives includes relaxation to update the e-profiles of seafarers who got stuck during the COVID-19 pandemic lockdown in various countries, recognized seafarers as **"Key Workers"** providing an essential service, arrangement for the vaccination of seafarers at Mumbai Port Trust Hospital, Mental Health helpline for the seafarers and their families by associating with the shipping unions and associations, Emergency Food Ration under Atmanirbar Bharat Abhiyaan and the list may go on...

NUSI will miss his good work and co-ordination amongst the seafarers and shipping fraternity in general.

NUSI wishes him all the best for his next innings hopes that he will continue to amaze us with his support even after his retirement.
